

**CITY OF THROCKMORTON**  
**MEETING MINUTES**  
**MARCH 14<sup>th</sup>, 2017**

1. Mayor Will Carroll called City Council meeting to order at 7:00 p.m. with Council members Judy Jackson, Geneva Rodgers, Corey Keeter, Ricky Escalon and Brad Bellah present. Also present was Melanie Gober-City Secretary. Invocation was given by Will Carroll.
2. The Council reviewed the minutes from the February 14, 2017 meeting.

3. There was no one present for Citizens Participation. Mayor Carroll reported the following:  
There have been several water leaks this month but all have been repaired.  
Some of the streets are being patched, but the cold mix material should be used in warmer weather to effectively adhere to the surface being repaired.  
Mayor Carroll applied for a "Very Small Systems Grant" through the Texas Water Development Board. This grant will help us to make needed repairs to the water plant.  
Investigation on installing an irrigation system at the sewer plant to meet new TCEQ regulations is continuing.  
Mayor Carroll met with Mike Jones and three members of the TxDOT Aviation Division in Austin regarding the airport and the grants that are available to make repairs that are necessary to maintain/update the airport. He will continue to report on this as information becomes available.
4. Old Business:  
The condition of the Fire Hall was discussed; several people have been contacted but no one has turned in a bid to replace/repair the windows at the fire hall. Judy Jackson reported that she has done all she can to complete the grant until bids are received.  
Terry Barrington is volunteering his time and labor to build the fish habitat for the City Lake. There will be 20 of them made and placed in the lake soon.
