3.	Citizens Participation  No one was present for citizens participation. Judy Jackson brought up a suggestion that possibly in November the city could officially recognize our business owners by ordering a Proclamation in their honor. The council and Mayor agreed that this would be a good and positive way to help promote our local businesses. Mayor Carroll gave report on grant activities hoping that around October or November, we could start seeing the beginnings of repairs taking place.
	Mayor Carroll informed the council that he has been included on zoom meetings with several surrounding leaders on what is called <i>Connect the Nations/Texas</i> (Texas Rural Funders). Our county along with others, qualify for being above the 50% average that are without adequate internet service and therefore could qualify to get money to pay for infrastructure needed to bring in this new service. They will be helping us along with several others in town, to circulate a message that sends you to a link to take a 3-minute survey. This will determine if we have enough interest for them to build the infrastructure here. If there are not enough people to fill the survey out, then we won't even be considered for this service. It was discussed to share this link with all other business's and people in town through the city's website and on social media.
	Mayor Carroll presented to the council that Jimmy Collins wants the council to consider moving Jarrett Wigington to a full-time employee which would include Insurance and retirement. Jarrett has also shown interest in getting some of his water licenses. After some discussion, it was the consensus of council to ok the employment change concerning Jarrett.
	Highway signs for "truck breaks" coming into town were discussed. Susie agreed to call Rudy and see if he could contact the person in charge of this and get these signs up.
