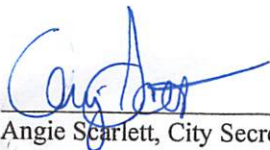


CITY OF THROCKMORTON  
MEETING MINUTES  
MONDAY, AUGUST 14<sup>TH</sup>, 2023

1. Mayor Will Carroll called the meeting to order at 6:00 p.m. with four (4) council members present. Brandon Chandler, Ricky Escalon, Lester Moses, and Cathey Lee. Council member Judy Jackson was absent. Also present was Angie Scarlett, City Secretary, and Jimmy Collins, Public Works Director. The invocation was given by Will Carroll.

Discussion on some of the prices that have been quoted by Windstream for regular customers and those that are senior citizens and disabled, having discounts. The sidewalk project should be starting their mobilization hopefully this week. Public Works Director, Jimmy Collins mentioned that the street project with Raydon will possibly be starting late September or October for Zada and Petit streets.
