Ms. Chambers will have a Felony Conviction on her record and will be responsible for paying all Court Costs as stated above as well as Probation Fees and Community Service.

Kim Bundy addressed the council regarding Ms. Chamber's trial. She was in the courtroom throughout the trial which lasted for four days and it was really a tough time for her. She also reported there have been many positive improvements made in the accounting practices at City Hall. The City no longer accepts cash for utility payments, there is a receipt written for all payments received, the receipt books are added by both the Asst. Secretary and the City Secretary and then balanced with the deposit slips to show all money is there. The City has changed their Utility software from Inhance to RVS; RVS shows at the end of the month any adjustments made to an account and what the adjustments were for. There are always ways to improve and we are always trying to find better ways of doing things to insure we are operating as correctly and efficiently as possible, it will always be a work in progress.
