## REGULAR MEETING RECESSES - PUBLIC HEARINGS BEGIN

 A public hearing was conducted to consider an Ordinance adopting a budget for the City of Throckmorton, for the Fiscal Year beginning October 1, 2013 and ending September 30, 2014.

This budget will increase total property taxes compared to last year's budget by \$1,161.00, and of that amount \$1,139.72 is tax revenue to be raised from new property added to the roll this year.

10. A Public Hearing was conducted to consider an Ordinance establishing the ad valorem levy tax rate for the City of Throckmorton for the Fiscal Year 2013-2014 at 0.98076 per 100-dollar valuation of property, representing a levy of 0.81881/100 for operations and maintenance, and .16431, for interest and sinking (Debt service).

No one was present to attend the Public Hearing, so the Council moved back into regular meeting.
